Rehearsal Policies:

Students must be warmed up, set up and ready to begin rehearsal promptly at 12:20. Be sure to have all necessary music and equipment (including a pencil and any required mutes). It is expected that you will prepare your music between rehearsals and arrive ready to play your parts.

Your grade in this course will be based on your attendance, participation, and development as a musician. Bearing your individual responsibility will make it possible for this group to be an outlet for your musical growth.

Because of the nature of chamber music, it is essential that you be present at every rehearsal and performance. ***Each unexcused absence*** from this class will lower your final grade by one increment (a B becomes a B-). ***Any unexcused absence from a performance will result in an automatic failure of this course.***
