Macon County EMS Student / Ride-along Policy

Attendance

- 1. Students ride time must be scheduled in advance.
- 2. Students should arrive on time at the beginning of the shift, 08:00.
- 3. Students should not stay later than 22:00 unless they are on a call.
- 4. Students should be prepared to ride as soon as they arrive.
- 5. If not currently enrolled in an approved teaching institution, prior authorization from Macon County EMS Administration must be obtained.

Attitude

- 1. Students will conduct themselves in a courteous, pleasant and professional manner in all dealings with employees, public and patients.
- 2. Discussions of the personal business of others will not be tolerated.

Confidentiality

- 1. Students will not discuss any patient information with anyone other than the Paramedic in charge of that patient.
- 2. Students found in violation of patient confidentiality will lose riding privileges.

Personal Appearance

- 1. Students are expected to be neat and clean when reporting for ride time.
- 2. Students will wear appropriate clothing in good, clean condition.
 - a. Hats, caps, etc. are not to be worn unless they are approved by EMS Administration.
 - b. Blue jeans of any kind are not to be worn.
 - c. T-shirts displaying any logo other than student's school affiliation can not be worn.
 - d. Students should wear sturdy shoes, preferably boots, to protect ankles from injury.
- 3. Students must wear some kind of identification showing who they are and who they are affiliated with.
- 4. If jewelry is worn it must not interfere with patient care.
 - a. Necklaces must be tucked inside the shirt collar so as to not fall in patient's face during patient care or get caught in stretcher during raising and lowering.
 - b. Rings should be limited to band type so as to not tear gloves or scratch patients during patient care.

- c. Earrings should be small, non-dangling type. If ears are pierced, earring should cover the whole so as to limit exposure to body fluids. NO OTHER VISIBLE PIERCING JEWELRY ALLOWED.
- 5. Hair should be styled so that it does not interfere with patient care. Long hair should be pulled back and secured so that it does not interfere with patient care.
- 6. Personal fragrances, if worn at all, should be such that is non-irritating to patients and co-workers.

Personal Visits

- 1. Students can not have visitors come inside the EMS quarters during their scheduled ride time.
- 2. If student must have a visitor during their scheduled ride time, they will meet in the parking area outside.

Personal Phone Calls

- 1. Personal phone calls by students on **County** phones will to be limited to local calls only and should last no longer than 10 minutes and will not delay responding to a call whether it is emergency or non-emergency.
- 2. Personal calls on County cell phones are not allowed.
- 3. Personal calls on personal cell phones will not delay responding to a call, whether it is emergency or non-emergency.
- 4. Cell phone use by students will not be allowed in the ambulance or while patient care is being preformed.

Vehicle Operations

- 1. Students will not, for any reason, drive, park, or move the ambulance.
- 2. Students are to be with patient in the patient compartment when ambulance is in route to the hospital.

Patient Care Authority

- 1. The Paramedic on board the ambulance is in charge of all patient care no matter the skill level of the student rider.
- 2. Students will not do any procedures without explicate permission of the Paramedic in charge.

I have read and understand the above guidelines and agree to abide by them to the best of my ability. I also understand that the Paramedic in charge can terminate my ride time for any reason pending an investigation by Macon County EMS administration.
